Qualification of Graduation for MSc. Student and Ph.D. Student

You can graduate from university when you have done all these activities.

1.Proposal Exam

<u>A Msc student</u> must be done within 3 semesters.

<u>A PhD student program I</u> must be done within 5 semesters.

<u>A PhD student program II</u> must be done within 5 semesters.

****If the proposal has not been examined in the due course, the student status will be terminated as the regulation of the Graduate School, PSU.****

*Ethical approval of proposal

Students must complete the preparation of document requested for EC approval. It must be done after proposal exam promptly before going back for data collection at home country.

Students have to submit their proposal for ethical approval from institute ethical committee of Faculty of Medicine. Please see the applications via this link: http://medinfo2.psu.ac.th/research/hrec/?q=node/5

2.English Exam

All students have to passed English test before course enrollment. English language test scores must be less than 2 years old at the date of course enrollment at the Department of Epidemiology.

PSU-TEP Examination

MSc and PhD students must have a minimum average score of 60% for reading & structure, listening and writing skill.

3. Publication

For MSc student must present his/her work in an academic conference with full article published in the proceedings accompanying the conference, or published in a peer reviewed journal indexed in the accepted databases (please see the list of journal databases for publication in https://grad.psu.ac.th/images/files_eng/News/news179.pdf).

For PhD student must publish at least one article from their thesis work in peer reviewed journals indexed in the accepted databases (please see the list of journal databases for publication in https://grad.psu.ac.th/images/files_eng/News/news179.pdf).

Additional condition for students who earned the THE-AC schorlaship from the Graduate School:

- MSc program: student must publish at least one article from their thesis work in ISI database journals
- PhD program: student must publish at least two articles from their thesis work in ISI database journals

Additional condition for others schorship, will be inform individually.

4. Thesis

-Students must take an exam within mid of May in academic year which you need to graduate.

-Students' thesis book (black or Blue cover) must be completed and submitted to Graduate School before the end of May. The students need to prepare the final thesis and check for accuracy of hard copy before sending to Educational Officer.
